INSIDE INFORMATION ANNOUNCEMENT

This announcement is made by WWPKG Holdings Company Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Rule 17.10 of the Rules Governing the Listing of Securities on the Growth Enterprise Market of The Stock Exchange of Hong Kong Limited (the “**GEM Listing Rules**”) and the Inside Information Provisions (as defined in the GEM Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The Company noted that an unauthorised party accessed the Group’s customer database on our system on 6 November 2017 (the “**Issue**”). The affected database contains information of our customers, which may include name, ID card number, passport number, phone number, email address, credit card information, mailing address and/or purchase history.

Upon discovering the unauthorised access, we immediately commenced a thorough investigation, which involved a comprehensive check of the affected system. Upon completion of such thorough investigation, we will implement appropriate upgrading of our system to defend against any further attacks. We have also reported the Issue to the Hong Kong Police Force and will assist in the investigation. The Directors confirm that the Issue will not have any material adverse impact on the Group’s operation and financial condition.

We are reaching out to every possibly affected customer to alert him or her of this data breach and the potential exposure of his or her personal information. We are committed to protecting our customers’ information and their privacy to ensure against any such incident in the future. We will continue to strengthen the security of our systems.

Shareholders and potential investors of the Company are reminded that the information provided in this announcement is based on the preliminary assessment of the currently available information by the Group’s management. Shareholders and potential investors of the Company are advised to exercise caution when dealing in the Company’s shares.
